Eligibility

All hounds 1 year of age and older from the following breeds: Afghan Hound, Azawakh, Basenji, Borzoi, Cirneco Dell'Etna, Greyhound, Ibizan Hound, Irish Wolfhound, Italian Greyhound, Pharaoh Hound, Portuguese Podengo Pequeno, Rhodesian Ridgeback, Saluki, Scottish Deerhound, Sloughi, Whippet.

Miscellaneous Group* :Norrbottenspets, Portuguese Podengo (Medio & Grande)Peruvian Inca Orchid

Foundation Stock Service (FSS)*: Thai Ridgeback

* May compete for suffix title only.

Dogs of these breeds recorded with the Purebred Alternative Listing Program/Indefinite Listing Privilege (PAL/ILP) or dogs with Conditional registration are eligible to participate.

Spayed and neutered dogs are eligible to participate.

Monorchid and cryptorchid dogs are ineligible to participate.

Bitches in season are not eligible to participate.

Hounds with breed disqualifications, as listed in the AKC Breed Standards, are ineligible to enter lure coursing trials and tests.

Dogs with Limited Registration are eligible to participate.

Stakes:

OPEN: Open to all hounds who have an AKC Qualified Courser certificate or an ASFA Certification; or an ASFA or CKC Field Championship. The certificate must be presented with the entry to be included with the results to the AKC.

OPEN VETERAN: Open to any hound that has met certification requirements who is 6 years of age, except Irish Wolfhounds who are 5 and Rhodesian Ridgebacks, Afghans, Salukis and Whippets who are 7.

SPECIAL: Open to any hound who has earned their AKC Field Championship title. LCX points will be awarded from this stake.

SINGLE: Hounds run by themselves, placements are based on scores.

Awards

Dark green ribbon for completing Junior Courser test.
Lilac ribbon for completing Qualified Courser test
First place, Blue ribbon, Second place Red ribbon, Third place Yellow ribbon, Fourth place White ribbon, Fifth place Pink ribbon
BOB Purple/gold rosette. BIF Red, White and Blue rosette.

Additional information

Hounds not present for at roll call will be scratched.
Hounds who have been disqualified at an AKC trial are not eligible to compete until recertified.
Hounds who have been dismissed twice are considered disqualified.
A fee of \$25 will be charged for returned checks
A fine of \$5 will be charged for any loose hounds on the field.
Course will be reversed for finals.
Lure will consist of highly visible plastic strips
IWAGS reserves the right to alter the course as required by weather and/or field conditions on the day.
The field is not fenced.
JC tests will run before the trial
QC tests will run after Best in Field
Single Stake is limited to 7 hounds.

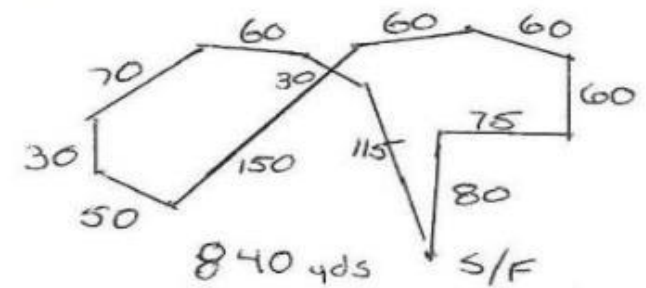

From the South: Take I-95N to exit 7b to merge onto US 206 North/bayard Ln/County Rd 533. Continue to follow 206 North. Turn right onto Amwell Road. Turn left onto Mettlers Road. Park will be on the left.

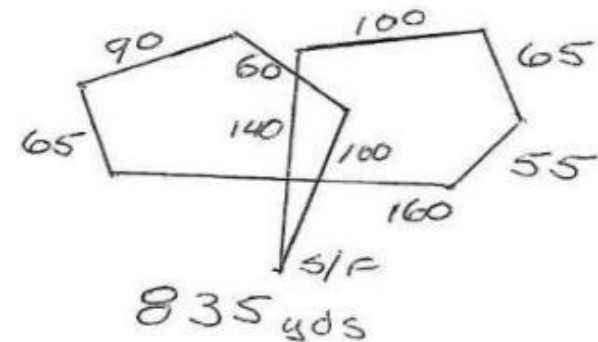
From the West: Take 78 East to Exit 29 for I-287 toward US202/206/180 Morristown/Somerville. Keep right at the fork to continue toward I-287S. Keep left at the fork following signs for I-287 S/Perth Amboy and merge to I287South. Take Exit 12 off 287 South for Weston Canal Road. Take 3rd left onto Randolph Road. Turn right onto Schoolhouse Road. Turn left onto Mettlers Road. Park will be on your right.
